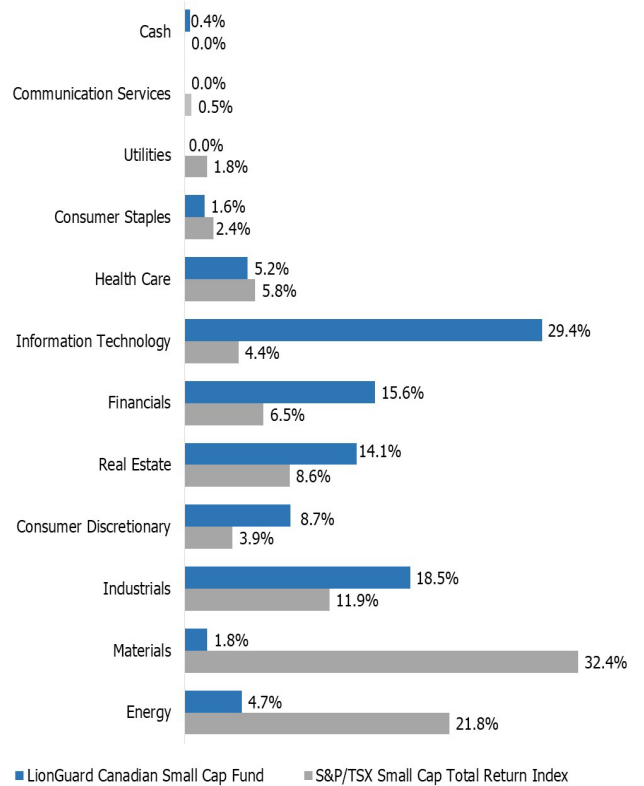
FUND DESCRIPTION

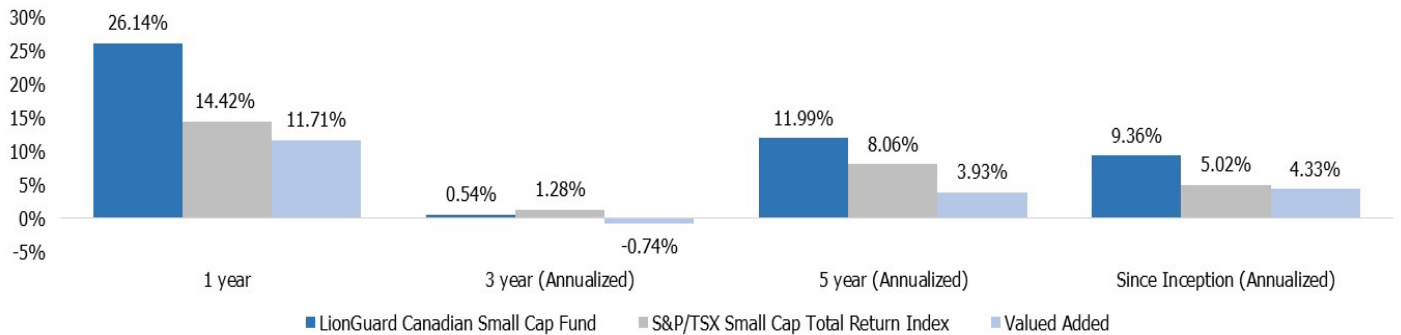
